This cause came on for hearing the 14th day of November, 1979, before Trial Referee Francis V. May, to whom this cause was referred by the Honorable James P. Celebrezze to try the issues of law and fact, arising under the provisions of Rule 53 and Rule 75 of the Ohio Rules of Civil Procedure, upon the petition of the parties and the evidence.

Upon due consideration thereof the Court finds that at least one of the parties was a resident of the State of Ohio for more than six months immediately preceding the filing of the petition; that the parties were married as alleged; and that no children were born as issue of the marriage.

11-19-79 No objections were filed thereto, and that therefore the parties are found to have waived their right to any further hearing thereon.

The Court further finds that the Petition for Dissolution of Marriage was filed on October 15, 1979; that service of process was duly waived according to law, and that attached to the Petition was a Separation Agreement signed by the parties, which is fair, just and equitable. The Court further finds that in open court the parties acknowledged that they still were in agreement as to the terms thereof and that there has been full disclosure by each of the parties of all of his or her assets. The Court further finds that a copy of said Agreement is attached hereto, marked Exhibit "A", and is incorporated herein as if fully rewritten.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the marriage contract heretofore existing between the parties be and is hereby dissolved and set aside, and the terms of the attached Separation Agreement are hereby ordered into execution.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Terry Embry pay the cost of this proceeding, for which judgment is rendered and execution may issue.
